

# CHAIRMAN'S MESSAGE

The Seamen's Church Institute, I am happy to report, continues to sail along at an ever-increasing pace. Not many institutions get to be 170-years-young, which suggests we have had, and continue to have, the right officers and crew to carry out our mission on behalf of mariners around the world.

This past year has seen all of our program activities expand significantly. Our Center for Seafarers' Services is responsible for a large part of our activities. These include, among others, ship visiting, religious services, monetary assistance for seafarers in need, counseling, Christmas gift packages for crews at seas and on the rivers during the holidays, and the distribution of books, magazines, and tapes to ocean, river, and gulf crews.

Our Center for Seafarers' Rights, in addition to its usual help to mariners on issues such as repatriation, wages, abandonment, death, illness and injuries, now is involved in reducing the obstacles facing shore leave restrictions generated from national security issues.

Our Maritime Education facilities continue to train mariners in navigation, firefighting, and Coast Guard requirements at our New York, Paducah, and Houston Centers. Those who have passed through these training facilities number in the tens of thousands. 2003 was the first year of a new subsidiary in SCI's umbrella. The startup of the Alliance of Episcopal Maritime Ministries, whose purpose is to share our experience and programs with other maritime centers throughout the United States, has, at last count, been joined by 19 port missions, and it continues to expand.

Our Executive Director, the Rev. Dr. Jean Smith, in her first full year at the helm, made great strides in improving existing programs as well as creating programs in keeping with our mission.

SCI's concerns for mariners worldwide make our activities exciting and rewarding and, hopefully, will set our course for the next 170 years. Our activities are many and widespread. That would not be so were it not for our loyal supporters. The last few years have not been easy for many notfor-profits. Expenditures have increased and, in our case, exceeded income. Your support can make the difference in keeping all our programs functional. Please do what you can to help.

On behalf of our board, our staff and the mariners we serve, thank you.

## SHIP VISITING

The Seamen's Church Institute's multilingual chaplains and trained volunteers visit 90% of all ships that enter the Port of New York/New Jersey – over 3,000 ships each year. Chaplains and Center for Seafarers' Rights staff members assist seafarers with family, employment, medical, and seafarers' rights concerns.

#### In 2003:

> Chaplains transported 24,911 seafarers in SCI vans.

> Chaplains welcomed 15,562 seafarers, along with more than 40,000 port workers and truckers, to SCI's International Seafarers' Center.

## 2003: SHORE LEAVE DENIED

Throughout 2003, hundreds of seafarers were confined to their ships without shore leave in American ports. Post 9-11 security-related restrictions escalated without regard to seafarers' unique situations.

SCI chaplains became experienced providers of pastoral care and social services to seafarers without shore leave. A chaplain's visit to a vessel where seafarers were denied shore leave lasted from three-tofive hours. The Institute purchased seven cell phones so that all crew members could contact home. Seafarers entering the Port of New York/New Jersey after 28-to-40-day voyages without affordable access to ship-to-shore communications were especially anxious to hear the voice of a spouse, parent, or child.

To help document shore leave denial, ship visitors participated in two nationwide surveys conducted by SCI's Center for Seafarers' Rights. The surveys highlighted the pervasiveness of shore leave restrictions. For example, from October 5 through October 11, SCI chaplains visited 68 ships. Of those 68 ships, 19 had mariners who were denied shore leave. The nationalities of those who could not set foot ashore included American, Filipino, Croatian, Montenegrin, Ukrainian, Russian, Korean, Indonesian, Greek, and Romanian seafarers. Projecting these numbers over a year, we could expect 25,584 mariners from 988 ships to be denied shore leave in the Port of New York/New Jersey.

# INTERNATIONAL SEAFARERS' CENTER

The International Seafarers' Center, located in Port Newark, serves the largest port complex on the East Coast seven days a week. It is the only place where all port workers including seafarers, truckers, warehouse workers, and stevedores can meet in a friendly and safe environment for a variety of services and relaxation.

- > Chaplains. Trained chaplains and volunteers provide hospitality and pastoral counseling.
- > Sports and Recreation. SCI's basketball court, soccer field, ping-pong and pool tables, video games, board games, and large screen satellite television provide a variety of ways to relax and socialize outside the confines of work.
- > Front Desk Business Services. The Center's information desk offers a variety of services, including internet access, telephones, fax machine, money orders, money grams, low cost domestic and international calling cards, overnight shipping, postage, priority mail, and UPS shipping.
- > Port O'Call Restaurant/Catering and Conference Rooms. The Port O'Call Restaurant, open weekdays for breakfast and lunch, also provides catering services throughout the port. Conference rooms are available for meetings.
- > Food for the Soul. The Mariners' Chapel, always open for prayer and meditation, offers daily services.

Ms. Ann H. Mills, a Presbyterian Elder and Lay Pastor, joined the MOR staff as the Coordinator of Special Projects. She had previously served as a Marketing and Communications Coordinator with the United Way of Paducah-McCracken County and as a Membership Development Specialist with the Girl Scouts of Kentuckiana.

Thirteen congregations joined the River Friendly Church network of 104 congregations that extends from Pittsburgh to New Orleans.

With 6,849 Christmas-on-the-River gifts distributed, 886 more mariners received a package than in 2002. Just over 300 vessels received devotional materials, candy, and cards during Holy Week from the 2003 Easter-on-the-River distribution.

Chaplains' work in schools expanded to kindergarten students and their 5th grade buddies at Doherty School in Cincinnati, OH.

Mariners from 11 companies participated in Ministry on the River's annual photo contest. Winners were 1st) Captain Ted Trosclair - Ingram Barge Co, 2nd) Mr. Kenneth Worthey - Missouri Barge Line, and 3rd) Mr. Bernie Bosarge - Waxler Towing.

# MINISTRY ON THE RIVER

Ministry on the River, established in 1998, provides hospitality and pastoral care to mariners and their families working on America's inland waterways. Mariners on towboats typically work 30 days at a time, and can be at home as little as 15 days between "hitches." Land-based support systems are not equipped to handle the mariners' unique challenges. Ministry on the River is the only support and pastoral network available to more than 30,000 inland mariners.

#### Ministry on the River staff and volunteers

- > visit mariners onboard vessels from Pittsburgh to Houston with SCI-trained chaplains and trained clergy associates.
- > maintain pastoral care, counseling, and emergency response – onboard and onshore through a toll-free number.
- > provide spiritual and practical support enabling mariners and their families to more effectively cope with the stress of working on the river.
- > network more than 100 River Friendly Churches of many denominations into ministry partners for pastoral care and assistance including ongoing initiatives such as the Pass-It-On video and book program, Christmas-on-the-River, and Easter-on-the-River.
- > speak to church groups, civic organizations, and school children about the challenges facing mariners and their families, the environmental benefit of riverborne transportation, and career opportunities in the maritime.
- > encourage congregations of all denominations to offer a Mariners' Sunday Service with liturgical resources provided by the Institute.

# INTERNATIONAL TRAINING CENTER FOR WORKPLACE MINISTRY (ITC)

## WorldHaven Network Cross-Cultural Immersion for US Seminarians

In response to the need for new and enhanced port missions worldwide, the Seamen's Church Institute established the International Training Center for Workplace Ministry (ITC). Interns from around the world train at Port Newark using the incomparable maritime resources of the Institute. ITC graduates are connected to SCI and to each other through the Institute's WorldHaven network. US seminarians participating in the Cross-Cultural Immersion program spend two weeks working with SCI staff and living in a Christian community with ITC interns at SCI House in Newark.

#### Curriculum

The ITC curriculum of action, study, and reflection enables interns to experience the vitality and technical management that lead to an effective port mission. In the process, they learn to handle the many challenges associated with today's seafarers, longshoremen, truckers, and others in the maritime workplace. Components include:

- > Legal, Civil, & Human Rights
- > Ship Visiting
- > Ministry to Truckers
- > Fundraising & Volunteer Development



## **Highlights for 2003**

SCI Liberia Director and WorldHaven Chaplain, the Rev. Ed K. Gbe, brings food purchased with funds sent by SCI New York to abandoned seafarers on the M/V Aqua Sierra.

SCI assisted WorldHaven Chaplain, the Rev. Ed Gbe, Director of the Seamen's Church Institute of Liberia in the Port of Monrovia, as he served an abandoned crew for six months during the Liberian civil war.

SCI representatives, the Rev. Dr. Jean Smith and Douglas Stevenson, along with those from the Paraná and Espírito Santos Baptist Conventions, opened a new Seafarers' Center on April 23 in Paranaguá, Brazil. SCI and its Brazilian partners support three Brazilian Centers, all within 375 miles of Rio de Janeiro.

SCI presented a Distinguished Service citation to the Yalta International Seafarers' Center on November 3 in the Ukraine for six years of exceptional service to seafarers.

## Alliance of Episcopal Maritime Ministries

The Seamen's Church Institute created the Alliance of Episcopal Maritime Ministries (AEMM) in January 2003 to draw together Episcopal port chaplains. For the first time on March 31, 2004, AEMM chaplains from ports around the United States met at the Episcopal Church Center in New York City. During the service in the Chapel of Christ the Lord, the Most Rev. Frank T. Griswold, Presiding Bishop of the United States, recognized the 19 port chaplaincies networked together by AEMM as a new chaplaincy served by the Rt. Rev. George Packard, Bishop Suffragan for Chaplains.

# CHRISTMAS-AT-SEA

The number of Christmas-at-Sea knitters across the country rose last year to 3,500 — a gain of about 500 new knitters. They work year-round making gifts that are opened by merchant mariners working shifts on Christmas Day. SCI chaplains, ship visitors, and members of River Friendly Churches deliver Christmas-at-Sea and Christmas-on-the-River gifts.

The Christmas-at-Sea package contains personal items along with a hand-knitted scarf and cap, socks, or vest. Inland mariners receive a slightly different package that includes a scarf as well as homemade cookies and candy wreaths.


SCI delivered gifts to 15,479 mariners during the 2003 Christmas season. Seafarers received 8,630 gifts and inland mariners received 6,849 gifts.


# PASSENGER SHIP TERMINAL

# CENTER FOR SEAFARERS' RIGHTS

SCI's Center for Seafarers' Rights (CSR) is a worldwide resource for legal research, education, advocacy, and assistance on seafarers' rights issues.

#### **CSR** lawyers

- > intervene directly in crisis situations such as those involving abandoned mariners.
- > promote improved conditions for seafarers in the United States and abroad with governments and international organizations.
- > assist seafarers in understanding their legal rights and remedies.
- > bring publicity to injustices such as illegal recruiting, abandonment, piracy, and unwarranted denial of shore leave.
- > provide training to port chaplains and ship visitors through workshops given in ports throughout the world.
- > educate port chaplains and lay ministers who train in Port Newark at the International Training Center (ITC) for Workplace Ministry.
- > train interns from New York area law schools and Tulane University Law School in New Orleans, LA.
- > maintain an electronic network of port-based missions to provide legal advice to chaplains and ship visitors.
